Page 1

- No complaints or grievances regarding any kind of gender bias or sexual harassment were received since the previous meeting.
- Female faculty have accompanied every study tour and field visit in the
 last half academic year and are scheduled to accompany students for
 further scheduled tours as well. They will also be part of extra-curricular
 activities like sports, culturals etc. through the college festival AAKAR
 2022 due to start on the 16th of December 2022, and ensuring further
 safety for female students.
- As per discussions with non-teaching staff, Ms. Madhura Swant, the staff
 is pleased with a healthy co-working environment and no complaints of
 gender bias or sexual harassment have been lodged since the last
 meeting of the CWDC.
- Facilities for female students, like the sanitary pad vending machine in the student's toilet is in working condition and is being monitored by staff Ms. Madhura Sawant.
- The student activity NASA has begun and students have been provided with adequate safety during their stay after hours on the premises for cocurricular and extracurricular activities - there is one staff member staying overnight on the premises, lighting is adequate and security personnel are accessible at all times.
- A proposal of trying to arrange a self-defense workshop for AAKAR 2022, similar to that conducted in AAKAR 2021 has been floated.
