



### Report on – Upload Sanction letter of Scholarship and free ships.

The Bombay Suburban Art & Craft Education Society's L.S. Raheja School of Architecture - Bachelor in Architecture - 5 year Full time Degree program is affiliated to University of Mumbai, approved by Council of Architecture - New Delhi, approved by Directorate of Technical education, recognized by State Govt. of Maharashtra and recognized by University Grant Commission (UGC) under section 2F.

The B.Arch. program has an approved intake of 80 students with additional 10% seats (8 seats) are received under EWS (Economically Weaker Section) category through Directorate of Technical Education (DTE). The centralized admission procedures of the eligible candidates for this B.Arch. program happen through MahCET cell and Admission Regulating Authority (ARA) as per the approved seat matrix of various categories viz., Open, OBC, SC, ST, NT, VJDT, physically challenged, Military service, etc. The fees of our institute are approved by Fee Regulating Authority (FRA).

The students pay the fees as per the approved fee matrix under various categories. The open category students pay the full academic year fee, whereas the students who receive admissions under categories are entitled to receive scholarships under various schemes by applying on the MahaDBT portal of the State Govt. of Maharashtra. Teaching staff and admin staff is assigned to counsel and assist the students to fill up and upload the stringent scholarship applications procedures.

The Samaj Kalyan (Social Welfare Department - SWD) office, after scrutiny approves these applications under various Govt. scholarship schemes and disburse the payments as per bills. The procedural lead time for all such scholarships amounts are almost 12 months. The students as applicants are notified by the SWD regarding their scholarship disbursement amount and only after they confirm the redeem status the amount is transferred to notified bank of the institute.

Specifically, NO formal Sanction letter is issued to the institute for the disbursement of the scholarship amount from the SWD department.

The B.Voc. (Interior Design) – 3 Year full time Degree program is Department affiliated to University of Mumbai, recognized by State Govt. of Maharashtra and University Grant Commission (UGC) under section 2F. This program has an approved intake of 60 students and the admissions procedures are conducted by our college on behalf of the University of Mumbai. The admissions are granted as per merit wise allotment list following the seat matrix chart DTE, State Government of Maharashtra. The program is considered under vocational course, the necessary mapping cannot be done and hence due to procedural reasons Govt. scholarships are offered to the B.Voc. (Interior Design) students.
